## Background story of composition.

The film composition "Sad Blues Man walking" is set in the early 1930s in Manhattan, New York, United States of America. The introduction of this composition presents itself in a solemn soft tone yet has created a suspenseful atmosphere within its 117 bars. The simplicity of the Acoustic Bass and the repetition also from the synthesized strings has developed the slow melancholic moving piece set in the A minor key.

The performing media are the Oboe, Nylon String Guitar, Piano, Synthesized Strings and Acoustic Bass used in the era of the 1930 that also help portray the image of the Mafia clan

The mood of the piece is depicted from the central character that is associated with the Italian Mafia. A man, medium built has joined the Mafia that has put him in a situation to take out tasks and projects within the clan. The drums played throughout the piece from the beginning to end create the movement as the man travels alone and with the clan. The heartbeat and suspense too is created from the drum beat and acoustic bass. The bass too creates a gangster feel that reinforces the Mafia theme. More instruments are introduced into the piece while the point of climax is found in the bars 57 to 69.

The rhythm pulse duration is played through the emphasis of the Bass Drum being syncopated and from the Acoustic Bass that is being plucked.

The tempo of the composition has been set at 120 however portrays both the slow yet moving effect from the contrasting instrument of the Acoustic Bass and Drums kit with the oboe and the piano.

The melody has been played and repeated with different motifs in 17 to 24 and 33 to 44 however is repeated that symbolizes the different notorious events that occur due to the joining of the Mafia Clan. Climax is within the solo that is not repeated in the piece unlike the other motifs. The melody depicts the image from the acquaintance of the Mafia scene, the gathering and negotiating of the notorious Mafia project, the action of bad deeds to the ending and destruction of the clan found in bar 57 to 60 the climax.

The acoustic guitar portrays the regret, from joining the Mafia group. As each motif from the oboe bar 17 to 24 and 33 to 44 come in and later repeated the acoustic guitar is played as the regret due to negative tasks and projects taken. The acoustic guitar is played in bars 1 to 6, 25 to 30, 45 to 50 and 113 to 117. The acoustic guitar also finished the composition and the man cannot get out of the Mafia clan, as he becomes haunted from the returning and never ending Mafia clan.

The homophonic texture is portrayed through the piano portraying innocence. The dynamics used within the piece are heard through the synthesized strings as a diminuendo and are also heard in the oboe. The dynamic unlike the innocence helps emphasize the Mafia theme in the era of the 1930s.

The structure of the music arrives with the acoustic bass and the drum kit, the Nylon String Guitar, Synthesized Strings, Piano and then the Oboe. Then slowly the instruments stop till what's left are only the Drum kits, Acoustic Bass and finishing off with the repeating of the introduction that has the repercussions from joining the Mafia group.
